Schmauss Award 2024

The Award Committee invites nominations for this year's Schmauss award*.

Candidates must have finished their PhD no more than 10 years prior to their nomination and should, during the previous three years, have published significant new results **in a field related to atmospheric aerosol science**. Career interruptions due to e.g. parental leave are considered eligible for extending the time periods. Candidates must be nominated by a member of an EAA member association but do not need to be members themselves. Nominations should include a letter of justification referring to specific achievements and publications, a *curriculum vitae*, a list of publications, and up to three supporting letters. We encourage nominations of women and ethnic minorities, who are currently under-represented among the past awardees. For more details see <https://www.info.gaef.de/awards>.

The 2024 Award will be conferred by the Gesellschaft für Aerosolforschung (GAeF) on the occasion of this year's European Aerosol Conference taking place in Tampere, Finland from August 25th to 28th. In recognition of the award, recipients will receive a certificate and share a monetary price of EUR 2,000. **The deadline for nominations for the Schmauss award is May 1st 2024.** Nominations should be sent in electronic form to the chair of the Award Committee:
